- 2 In Note #3 on Sheet C-501 the word “10%” shall be replaced with “5%.” The Contractor shall assume for purposes of this bid that 5% of the entire paved area will require stabilization.
- 3 The bid item #1 “Grade” shall include all costs of equipment, materials, labor, fuel, etc. required to grade the area of the new asphalt parking and roadway pavement to meet the grades shown or required in the drawings.
